### **1. Email Addresses & Profile Photos**

For the nature of this community and the workshops, groups, gatherings, live chat discussions and blogs; we require [your] self profile photo (not pictures of pets, other people, avatars) and your full (first, last) name within your email address.

### **2. Respectful communication**

Differences in opinion are natural and expected; however, personal attacks, hostility, threats, and insults are not acceptable. Peers should engage in respectful and courteous communication at all times. No cursing, swearing, or profanity.

### **3. No tolerance for hate speech or discrimination**

Racism, sexism, ageism and/or other forms of discrimination are not tolerated. Content promoting hate speech or prejudice is strictly prohibited.

### **4. Protecting user privacy**

Peers should never share personal information (theirs or others') in public forums without consent. This includes phone numbers, private messages, or other confidential information.

### **5. No explicit content, spam, requests for money or content that doesn't fit the community's focus.**

To ensure relevant and valuable conversations, spam, promotional content, and asking for donations (no Cash App, Venmo, PayPal or digital money app tags allowed.) and we may view/find other materials to be strictly prohibited as well.

\*All content that doesn't align with the community's focus will be removed.

## **6. No illegal activities allowed.**

Any discussions or content related to illegal activities — such as fraud, piracy, illicit drug use, or threats of violence — are forbidden.

## **7. Giving proper credit for shared content**

Peers must credit original sources when posting articles, images, or other materials.

## **8. Encouraging collaboration and support**

Communities thrive on knowledge-sharing and peer-to-peer support. We encourage peers to offer help, answer questions, and contribute valuable insights.

## **9. Prioritizing peer safety and reporting rule violations**

Any peer should report inappropriate behavior or content that violates our community guidelines. We are working to build a strong community management strategy to ensure that all reports are addressed promptly.

## **10. Blocking & Removal**

We hope that it will not come to this, but if the above rules are not followed we reserve the right to remove a peer from a group, online meeting, gathering and furthermore block from the community.
